Village Work Session Minutes
February 9, 2021

A Work Session Meeting of the Board of Trustees of the Village of La Grange Park, Illinois was scheduled on February 9, 2021 at 7:30 p.m. via Teleconference due to COVID-19.

Village President Discipio called the meeting to order at 7:32 p.m. President Discipio stated for the record that the meeting was being held remotely due to COVID-19 and confirmed that all participants could hear. Public Participation

Public Works Committee

Trustee Michael Sheehan read the Agenda Memo Item Risk and Resilient Assessment/Emergency Response Plan – Engineering Agreement. Public Works Director Rick Radde stated one of the main components of the RRA is cyber security. He stated the last review was conducted in 2004 and the Risk and Resilient Assessment would look into the Village’s security and address any credible threats. Village Manager Julia Cedillo stated the project was being budgeted for in the upcoming proposed budget which would be forwarded to Board Members in March. At the end of the discussion, Trustee Sheehan made a Motion: *To Approve a Professional Engineering Agreement for a Risk and Resilient Assessment and Emergency Response Plan in the Amount of \$26,400.00 and to Authorize the Village Manager to Execute Required Documents. The motion was seconded by Trustee Koncel and passed unanimously by roll call vote.*

Other Reports

President Discipio called upon Village Manager Julia Cedillo for a report. Village Manager Cedillo had several items to report on. Village Manager Cedillo thanked Public Works Director Radde for the overview of the Risk and Resilient Assessment/Emergency Response Plan that he presented to the Youth Commissioners at their Monday night meeting.

Village Manager Cedillo stated that Village Staff had recently received several complaints regarding the delayed postal service throughout the Village. Village Staff had reached out to the La Grange Post Office with no response as of

Mr. Adam Winter of Congressman Quigley's office responded to Staff and provided a link where constituents could provide a complaint. Village Manager Cedillo stated that if residents do not have access to a computer, they can call the Village Hall and Staff can help them complete the form.

Village President Discipio had one item to report on. He thanked Police Chief Contois, Fire Chief Maggos, Public Works Director Radde, and their departments for their hard work in dealing with the recent snowfall and cold weather throughout the Village.

President Discipio called upon Village Clerk Meghan Kooi for a report. There was nothing to report.
