

Village of La Grange Park
Youth Commission- Meeting Minutes
February 12, 2018

A meeting of the La Grange Park Youth Commission was called to order at 7:00 p.m. on Monday, February 12, 2018 at the La Grange Park Village Hall.

1. Call to Order

2. Public Comment

3. Approval of Minutes- January 8, 2018

6. Review of Village Board Work Session Meeting of February 12, 2018

Charlotte Phillip summarized the Village Board Agenda Memo regarding the Regional Disposal Project. At the end of the discussion there was a *Consensus to Approve a Resolution of Continued Support of and Participation in the West Cook County Solid Waste Agency's Regional Disposal Project.*

Charlotte Phillip summarized the Village Board Agenda Memo regarding Cork, Keg & Spirits' Liquor License Request. At the end of the discussion, there was consensus to consider amending the Village's regulations to accommodate the request.

Charlotte Phillip summarized the Village Board Agenda Memo regarding the rezoning of La Grange Road. AVM Rodman provided some additional background and context of general land use and zoning principles. After much discussion, the Commission reached a consensus that staff should submit an application for a map amendment to pursue the rezoning of certain properties along La Grange Road.

Charlotte Phillip summarized the Village Board Agenda Memo regarding the following Public Works Committee items.

- A. Purchase of 2018 GMC 3500 Chassis
- B. 2017 Patching Program
- C. 2018 Road Paving Program
- D. 2018 Sewer Repairs Project

Following the discussion on each of the items and due to their routine nature, the Commission reached a consensus to recommend approval of all four items.
