6. Review of Village Board Work Session Meeting – January 10, 2023

Sophie Marczuk provided an overview of agenda item (6A) Konica Minolta Lease Agreement. Upon conclusion of the discussion, there was consensus to approve a *Motion: To Waive The Competitive Purchasing Process And Enter Into A Five-Year Lease Agreement With Konica Minolta For Two New Copiers, And Authorize The Village Manager To Execute The Necessary Documents.*

Riley Mulhall provided an overview of agenda item (6B) Video Gaming Ordinance Discussion. The Commissioners discussed the benefits and risks to repealing the ban on video gaming.

Katherine Suttle provided an overview of agenda item (6C) Amendment To The La Grange Park Municipal Code - Alcoholic Beverages. Upon conclusion of the discussion, there was consensus to approve a *Motion: To Approve An Ordinance Amending Chapter 112, Section 20, Of Title XI Of The La Grange Park Municipal Code To Decrease The Total Number Of Authorized Class A And Class B Liquor Licenses From Nine To Seven.*

Katie Beyer provided an overview of agenda item (7A) 555 N. Kensington Avenue - Subdivision Request (Case #22- 0009). Upon conclusion of the discussion, there was consensus to approve a *Motion: To Approve An Ordinance Approving A Plat Of Subdivision For 555 N. Kensington Avenue - Case #22-0009.*

Connie Anagnos provided an overview of agenda item (8A) Illinois Public Works Mutual Aid Network (IPWMAN) Agreement. Upon conclusion of the discussion, there was consensus to approve a *Motion: To Approve An Ordinance Authorizing Execution Of The Illinois Public Works Mutual Aid Network Agreement (IPWMAN).*
