Upon conclusion of the discussion, *there was consensus to approve a Motion: To Approve An Ordinance Authorizing the Sale of Surplus Property Owned By The Village Of La Grange Park, Illinois by Julia Reven. The motion was seconded by Katie Beyer and passed unanimously by a voice vote.*

Julia Reven provided an overview of agenda item (8A) Tree Trimming Contract Award. Upon conclusion of the discussion, *there was consensus to approve a Motion: To Approve a One-Year Contract Between the Village of La Grange Park and Winkler's Tree Service for Tree Trimming in the Amount of \$46,000 and Authorize the Village Manager to Execute Necessary Documents.*

Julia Reven provided an overview of agenda item (8B) 2021/2022 Sewer Lining Project. Upon conclusion of the discussion, *there was consensus to approve a Motion: To Accept the Bid Proposal from Visu-Sewer of Illinois in the Amount of \$95,195.00 and to Authorize the Village Manager to Execute the Contract Documents.*

Julia Reven provided an overview of agenda item (9D.1) Proposed Economic Incentive Agreement for 716 E. 31st Street. Upon conclusion of the discussion, *there was a motion to approve a Motion: To Adopt an Ordinance Approving an Economic Incentive Agreement By and Between The Village Of La Grange Park, Cook County, Illinois and Level Up Cafe & Recovery, LLC by Katie Beyer. The motion was seconded by Charlotte Sands. Will Aikens and Sophie Marczuk were not in favor of incentivizing the business. The Commission did not reach consensus.*
