After the discussion, there was a consensus to *approve the Motion: To Approve A Resolution Approving And Authorizing The Execution Of A Second Addendum To Consulting Service Agreement For Public Affairs Representation Between The Village Of La Grange Park And Taft Stettinius & Hollister LLP (Village Lobbyist)*
